Attachment 4 Survey methodology

On Sun, May 20, 2012 at 2:26 PM, DJ Arnoldo wrote:

I plan to add new questions to the survey asking which venue people prefer, Vienna or Herndon, and whether people come to the event from work or from home, if we can work those in.

As Chair, there are a few things that you should understand about the VoC survey that I did not have time to explain during the Board meeting.

1. Work vs. home location: The argument is that the ASQ member map shows that members live uniformly distributed throughout the Metro NoVA area, so it doesn't matter where we have the event. This is wrong for two reasons.

a. By rotating the venue we engage different geographical member segments, which broadens participation in ASQ even if we get the same headcount at a specific event. For example, last time in Vienna I counted 13 new faces that were not Herndon regulars.

b. The data suggests that more people come to the event from work, not from home (we need to test this hypothesis). If true, then the home member distribution is not as relevant as the work member distribution, which is surely concentrated around the Beltway. The challenge for attendees is getting to the event in rush hour traffic, not getting home at 9 PM. This may be why members consistently request that we find a venue closer in.

2. Statistical validity of the VoC analysis: Some people say that VoC survey results are not valid because the sample size is small. That is absolutely not true for the following reasons.

a. Descriptive vs. Inferential Statistics: The stats we present each month are Descriptive, not Inferential. That is, the purpose of the analysis is to probe the needs and preferences of the survey respondents, not use the sample to infer characteristics of the population of "All Section 0511 ASQ members". The VoC survey observations absolutely are valid for the population of "People who attend ASQ Section 0511 events" because nearly everyone who attends the events has taken the survey.

b. "Lead User" Market Research Methods: Something very important differentiates the VoC survey respondents from the broader ASQ membership: they actually attend Section 0511 events. It is well known in market research that to understand your market, study your customers. That is, your customers appreciate the benefits of your product more than non-customers, and through them you can understand your value proposition and how to present it most effectively. For this reason, "lead users" get invited to focus groups because their preferences teach you the most about your target market. Even when designing new products, focus group members are screened based on fitting the "lead user" profile. There is value to studying the general population, but studying and understanding your customers' preferences should be done before "prospecting" in other market segments.

Here is my proposal for the VoC objectives for the coming year.

Goal: Understand the needs and preferences of the broader population of ASQ Section 0511 members, and compare these to VoC data on event attendees.

Conduct an email/online "2012 Section 0511 Membership Survey". We can only do one email/online survey a year, so let's incorporate Si Weaver's and Bob Zimman's questions into the survey to be sent out in June. (Bob and Si are CCd on this email.) I also plan to have another look at last year's online survey results, and compare this to the aggregated event VoC survey results.
Analyze the event VoC survey responses for the past year in aggregate. This should be more informative than the single event data, and provide ideas for events and ways to reach a broader segment of the membership.
