
Our membership numbers are down for this year from past years. We should call our unpaid members and chat with them about renewing and discussing the new focus of ASQ and our position to support quality globally.


We need to hold our first planning session for the September 2013 Membership and 30^{th} Year Celebration for the ASQ Northern Virginia Section 0511.
