- 5. Old Business Items from last month's board meeting or August's visioning meeting
 - a. Quality Management Plan Melissa
 - I took a look at the QMP and created a slide (#4) with some potential section objectives.  - b. Arrangements Question On the average how many paid attendees do we have (not counting board members who eat gratis if they attend the board meeting) – or, in other words, how much do we lose at each meal?
 - c. Topics for Board Vision meetings from Paul:



- i. We need to identify teachers for other certification exam preparation courses. I suggest focusing on Six Sigma Green Belt, Manager of Quality/Organizational Excellence, and Software Quality Engineer. Use the records of who from our Section has passed these exams and are eligible to teach, and then contact them as to their interest and availability and offer assistance in preparing materials for courses. I found the 3, 4, or 5 weekend all-day Saturday sessions to be better received than 10-12 weeknight sessions. In addition, we should push the use of virtual training, WebEx etc. seminars so people can stay at home rather than commute to a central location, with the related hassle of securing an acceptable venue. We should have several instructors for each course, to rotate them so they stay fresh and don't burn out.
- ii. We could do more to make it compelling to be certified—have speakers at each meeting, maybe 5 minutes, tell how they have benefited from ASQ national and section membership, as well as from their certifications. In my courses, I show students how a career progression is aided by successive certifications (CQA, CMQ/OE, SCQE, SSGB, etc.). In addition, let's provide recognition for achieving certification—free meals, gifts or gadgets, plugs in the Section newsletter and website, etc. Celebrate Certifications!
- iii. We have to reach more of the younger members and potential members, and that may mean targeting local colleges and universities for recruiting and signing up student members who become full members upon graduation. We should direct at least one dinner a year to students, give them a subsidized meal in return for their listening about ASQ and a topic of interest to them. It would be great to start on-campus student groups that our Section can support.
