### 4. Results of Partners in Excellence Symposium – Law

This was the first annual event, held at the Applied Physics Laboratory on the campus of Johns Hopkins University. 128 attendees were present. ASQ Section 0511 is a member of this Partners in Excellence group. This group is now meeting monthly to plan for next year's event. Call for papers will go out in late summer/early fall. Have reserved same facility for March 2002.

## 5. Region 5 Conference Planning Update – Law

The conference is scheduled to be held in Columbia MD, at the Johns Hopkins Applied Physics Laboratory. Planners are expecting several hundred participants. Our section Chair (Jim Coley) and Chair-Elect (DJ Law) have participated in conference calls and other meetings to address planning issues. The Section will sponsor DJ Law to attend and participate in the conference.

### 6. Paid Advertising/Personal Advertising – Casti

The E-Media Chair (Bill Casti) has received several requests from individuals who want to advertise quality-related events, services, and products on our section's website. The Board agreed to apply the same protocols and criteria as used in selling advertising space on our newsletter. Bill will develop an appropriate fee structure and present it to the Board for consideration at the next monthly meeting.

The Board determined that it is not appropriate to mix personal business with ASQ business in messages to the general membership.

## 7. Reports from Committee Chairs – All

<u>Publicity</u>: The phone line has been updated as appropriate.

Membership: As requested at last month's Board meeting, the Committee Chair (Bill Eastham) provided the Board with maps depicting the footprint outlined by membership addresses for Section 0511. (ASQ breaks up sections by zip codes.) Based on a review of this information, the Board determined that the current locations for dinner meetings served a large portion of the general membership, and that an additional location around Alexandria and/or Annandale should also be considered. The Programs Chair will look into these locations.

<u>Examining</u>: Exams are on schedule. There is a decline in people taking the exams and recertification, which correlates with the decline in membership. ASQ is holding a pilot exam for 6 Sigma Black Belt on 6 May and 2 June (150 questions).

Historian: Asked for membership breakdown.

<u>E-Media</u>: Science Fair judges looked at 310 projects and awarded \$200 to the top 4. The Board had previously agreed to provide \$500 for awards. AQC (Bill Casti) will provide the remaining \$300. Judges may claim 0.1 re-certification units per hour served.

#### 8. Other Business

We have not received any scholarship requests to date. May need to look into recirculating the information.

The Board clarified that a Board member must either be physically present at the Board meeting or conferenced in by phone to participate in voting activities.

Noting no further business, the meeting was adjourned
