

ASQ SECTION 0511 BOARD MEETING MINUTES 19 SEP 2012

Location: Amphora, Vienna Attendees: Under separate cover

- 1. Call to Order/Statement of Quorum–The Chair confirmed quorum and called to order at 5:37 PM.
- 2. Reading & Approval of Minutes–Aug 2012 minutes were read and approved as written.
- 3. Officer Reports/Announcements
 - a. Chair (Jeff Parnes): We reserved the Amphora Herndon facility for tonight, the Amphora Vienna for October, and then back to the Herndon Amphora in November. For each dinner plus dessert, the Herndon Amphora charges us \$28.95 + tax + 20% service charge without a room charge. That works out to about \$36.19 per meal for which we charge \$25. There was a discussion about the possible need to raise the unit cost to the members.
 - b. Chair Elect (Melissa Butler): Section Facebook and Twitter are up and running. Will announce again to the membership during the dinner meeting.
 - c. Treasurer (Roberta Pek): The Board approved a motion to accept the Treasurer's report for Aug 2012. If doing expenses with the credit card need to fill out the form. There are a couple of charges on the credit card bill for which she lacks documentation. Will include these in addendum to the minutes with request for documentation. Outstanding items from the financial audit will be resolved and closed.
 - d. Secretary (Yvonne Fernandez): Nothing to report. Will work with Chair Elect on Quality Management Plan.
