Eligible nominees will:

- 1. Be Senior members in good standing.
- 2. Have served in an elected section position: Chair, Chair-elect, Vice Chair, Secretary or Treasurer.
- 3. Not hold another elected position in the society during the term for Regional Director, except as a Board member or Section Affairs Council Chair or Vice Chair elected by the Section Affairs Council.
- 4. Review the Regional Director position description and confirm willingness to serve prior to submission

Nominations will include:

- 1. Nominee name
- 2. Nominee member number
- 3. Nominee biography of no more than 100 words
- 4. Nominating section (must be submitted by the Chair)

Please confer with your leadership committee and potential candidates as soon as possible and submit the nomination on behalf of your section by May 31, 2013.

Congratulations on finishing your ASQ examination!

As you unwind from your rigorous test preparation, consider joining ASQ Northern Virginia Section 0511.

We are a group of quality professionals who meet monthly, on the second Wednesday, for a dinner meeting and a presentation on some aspect of quality. By virtue of being in the National Capital Area, we are able to attract locally based national experts as our speakers. In addition, there is ample opportunity to network with colleagues across the quality spectrum.

These meetings count towards your ASQ recertification to keep your credential(s) without the need to re-test.

ASQ recertification requires 18 recertification units (RU) every 3 years. The maximum Recertification Units a person can earn by attending meetings in a 3-year period is 9.0, which when combined with the 10.8 units for full-time employment is enough to recertify. Other RU credits are also available by volunteering your time and service in focused projects, such as proctoring an ASQ exam, serving as a Section officer, being an instructor for an ASQ preparatory course, or many other avenues.
